Electronic Blue Book Licence Agreement

IMPORTANT - READ CAREFULLY: This ELECTRONIC BLUE BOOK Licence Agreement ("EBBLA") is a legal agreement between you (either as an individual or a single entity) and the Social Planning Council of Kitchener-Waterloo ("SPCKW") for the Electronic Blue Book, which consists of data stored in a database, a search application, and may include associated media, printed materials, and "online" or electronic documentation, all referred to herein as the "Blue Book". By installing, copying, or otherwise using the Blue Book, you agree to be bound by the terms of this EBBLA. If you do not agree to the terms of this EBBLA, do not install or use the Blue Book; you may, however, return it to your place of purchase for a full refund.

BLUE BOOK LICENCE AGREEMENT

The Blue Book is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The Blue Book is licenced, not sold.

1. Definitions

1. **The Blue Book** consists of the following components;

- a. **"Blue Book Database"**: data stored in a Microsoft Access database.
- b. **"Search Application"**, which provides an interface to the data.

2. **"User"** means any person who is employed by you (as an employee, independent contractor, or in any other capacity) or a client to whom you provide a service.

3. **"External User"** means anyone other than a User.

2. Grant of Licence

This EBBLA grants you the right to install and use copies of the Blue Book on the number of computers for which you have paid licence fees, such use being restricted to a User. External Users may not use the Blue Book.

3. Description of Other Rights and Limitations

- **Not for Resale Software.** You may not resell, or otherwise transfer for value, the Blue Book.
- **Limitations on Reverse Engineering, Decompilation and Disassembly.** You may not reverse engineer, decompile or disassemble the Blue Book, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.
- **Rental.** You may not rent, lease or lend the Blue Book.
- **Support Services.** SPCKW shall provide support services for the Blue Book at such times, and in such a manner, as shall be determined by SPCKW in its absolute discretion.
- **Software Transfer.** This EBBLA is not transferable.
- **Termination.** Without prejudice to any other rights, SPCKW may terminate this EBBLA if you fail to comply with the terms and conditions of this EBBLA. In such event, you must destroy all copies of the Blue Book and all of its component parts.

4. Upgrades and Future Versions

The data in the Blue Book Data Base is time sensitive, and will gradually become obsolete. It is the intention of SPCKW to make available monthly updates to the Blue Book Database. As well, SPCKW intends to make available updated versions of the Search Application, at intervals of one to two years under a new EBBLA. SPCKW accepts no liability or responsibility for any continued use by you of superseded versions of the Blue Book.

5. Copyright

All title and copyrights in and to the Blue Book (including but not limited to any images, photographs, animations, video, audio, music, text, and "applets" incorporated into the Blue Book), the accompanying printed materials, and any copies of the Blue Book are owned by SPCKW or its suppliers. The Blue Book is

protected by copyright laws and international treaty provisions. Therefore, you must treat the Blue Book like any other copyrighted material except that you may install the Blue Book on computers as allowed by this EBBLA, provided you keep the original solely for backup or archival purposes. You may not copy the printed materials accompanying the Blue Book.

6. U.S. Government Restricted Rights

The Blue Book and documentation are provided with RESTRICTED RIGHTS. Use, duplication, or disclosure by the U.S. Government is subject to restrictions as set forth in subparagraph c(1)(ii) of the Rights in Technical Data and Computer Software clause at DFARS 252.227-7013 or subparagraphs c(1) and (2) of the Commercial Computer Software-Restricted Rights at 48 CFR 52.227-19, as applicable.
